I, the undersigned, understand I am applying to adopt an Equine from The Wild Beauty Foundation ("WBF"). I understand my application must be expressly approved by WBF in order to adopt the above referenced Equine.

A \$100 deposit is required to process and review this application. If my application is approved, the deposit will go toward the total cost of the adoption fee of my Equine. If I choose not to adopt for any reason whatsoever after submitting this application, my adoption fee will be non-refundable. If my application is denied by WBF for any reason, my deposit will be refunded to me.

I understand that my application for adoption of the Equine may be conditionally approved, and I may be asked for additional information by WBF, including but not limited to photos of where my Equine will be living, boarded and/or trained; an in-home inspection, and the like if WBF so elects before final approval.

I also understand that I may never sell, give away, donate, lease out, send to auction, send to slaughter, or otherwise transfer ownership (except to a family member), the Equine I adopt. If for whatever reason I am no longer able to care for this Equine for any reason, I will give WBF the first right of refusal to adopt the horse back at zero monetary cost whatsoever to WBF.

I agree WBF is not liable for any reason or under any legal theory whatsoever in the event of injury, damage, or death to any human, animal or property as a result of activities or actions of the Equine I adopt.

I further agree and acknowledge that I am adopting an Equine from WBF that may have come from unknown circumstances (i.e. rescue situation, foster situation, kill pen, government holding facility) with limited information, and that notwithstanding, an Equine's background, disposition, temperament, training and abilities are ultimately unknown

and unpredictable. Therefore I agree to hold harmless The Wild Beauty Foundation and all its employees or agents, from any and all damages, injury, or death related thereto.

Further, if any third person makes a claim against WILD BEAUTY, LLC or any of its employees or agents as a result of any conduct of the Equine(s) in my possession, I agree to indemnify and hold WILD BEAUTY, LLC, its employees and agents harmless from any such claim, including costs and attorney's fees resulting from or relating to such claim.

WBF MAKES NO WARRANTIES, EXPRESS OR IMPLIED RELATED TO THIS ADOPTION, AND SPECIFICALLY EXCLUDES THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A SPECIFIC PURPOSE.

WBF will make reasonable efforts to disclose the information AS WE KNOW IT about each Equine, but I understand that WBF may have little or no information about Equine's background, temperament, or state of health.

I agree to hold harmless WBF from any medical conditions, underlying medical conditions, and the like, and further, from any representations of original description or training/riding ability of the Equine.

Upon approval of my application, I understand and agree that I must sign a legally binding adoption agreement prior to taking possession of the horse.

I understand and agree that all decisions regarding applications for adoption shall be in the sole discretion of WBF, are final and without recourse. The terms and conditions herein shall survive adoption and title transfer.
